## About the position

The position supports the Managing Director of Manufacturing SASU in defining the best business models to develop EIT Manufacturing's financial growth and in tracking the execution of all services and commercial agreements, ensuring that projects are on track and that revenue streams match the expectations. Manufacturing SASU is a 100% owned and controlled subsidiary of EIT Manufacturing.

# **Key Accountabilities**

#### Monitoring and review of the service agreements in relation to Calls for Proposals

- You coordinate among the different lines of business the consistency of the revenue mechanisms for all service agreements.
- You use the standard framework for commercial service agreements and negotiate if needed with third parties the terms and conditions for all contracts, you intervene as a support to the different lines of business.
- o You organize webinars and materials to explain how it works, what to do and what not to.
- o You train internally the relevant people to increase their awareness on financial stakes.
- You assist the Pillars (Innovations, Educations and Business Creations) in following the development of projects and activities, to ensure that they are on track with their commercialization plan.





## Financial controlling for commercial services

- You support the Managing Director of Manufacturing SASU in developing the portfolio of services, making sure that the profitability of services is ensured and that the transfer pricing between the different EIT Manufacturing entities is implemented properly.
- You work together with the Finance Team to raise the Return of Investment approach competences, and business mindset within EIT Manufacturing.
- o You support the Managing Director of Manufacturing SASU in monitoring the delivery of the commercial services, the Regional hubs and the external partners; when applicable, you track the payment of management fees or dividends.

## Qualifications and experience

- Minimum of 5 years of experience as Business / Financial Controller.
- Good knowledge of financial mechanisms and comfortable with reviewing contracts.
- Willingness and ability to go beyond improving processes and propose new ideas to continuously improve all processes.

- Very organized, proactive, service-oriented, capable of multi-tasking.
- Expert user of software tools such as Office tool suite, especially Power Point and Excel.
- Knowledge of public funding or international organizations considered a plus.
