2. General conditions

2.1 EIT Manufacturing's mission and strategic objectives

Mission

EIT Manufacturing will put Europe at the centre of a global revolution and boost manufacturing innovation in Europe by connecting people with skills, technologies with markets, and innovators with investors. Technological progress is now exponential, and it is changing the industrial, social and competitive landscape faster than ever before. The aim of EIT Manufacturing is not only to adapt to this revolution but to lead it. To do so, EIT Manufacturing need to overcome value network fragmentation and bring stakeholders together, leverage knowledge and strengths to create value, and implement agile mechanisms to accelerate innovation. With the needs, concerns, and ideas of the economy and society at its core, the mission of EIT Manufacturing is to empower its partners and stakeholders to fundamentally transform the manufacturing system and meet the global demands for present and future generations.

EIT Manufacturing's "BoostUp! Iberia 2024" edition is a competition for spin-offs, early-stage startups, and mature startups established in Portugal and Spain. It is an instrument for EIT Manufacturing to stimulate their ecosystem to scout and screen the most innovative solution providers in technologies supporting the transition to net zero industry. This is a continuation of the BoostUp! activities in 2020, 2021, 2022 and 2023. The geographical focus in Portugal and Spain is adapted to changing ecosystem needs, allowing engagement with the full manufacturing innovation ecosystem in both countries to detect the best applicants and companies and award them.

STRATEGIC OBJECTIVES

EIT Manufacturing's strategic objectives (SOs), as set out in the Strategic Agenda 2021-2027, steer our activities and ambitions, and will help respond to major challenges shared by the manufacturing industry and society.

- Put people at the centre of manufacturing.
- Accelerate green manufacturing.
- Foster sovereignty and competitiveness.

3. Competition specific conditions

3.1 Competition objectives and applicant's profile

OBJECTIVES

"BoostUp! - IBERIA 2024" is an EIT Manufacturing competition for spin-offs, startups, and scaleups established in Portugal and Spain in the manufacturing sector working on net-zero industry technologies ready to scale up across Europe.

APPLICANTS' PROFILE

The applicants must meet the following conditions at the company level:

- must be a spin-off, startup, and scaleup based in Portugal or Spain
- must prove revenue traction (existing reference customers).
- is **NOT** a Partner Member of EIT Manufacturing or a Linked Third Party of a Partner Member of EIT Manufacturing.
- shall have a PIC Number¹ before the call deadline. If the company has already participated in projects funded by the EU before and has a PIC number validated, it can proceed with the registration of the company on the submission tool. If this is the first time participating in an EU-funded project or the company cannot access the already validated PIC and there are updates to the organisational data that need to be done, the company need to register/re-register the organisation. Primary registration (declaration) of the PIC number takes about 10 minutes, and the PIC number is generated within another 10 minutes and is sent to the email address indicated during the registration. All new PIC numbers get assigned a status of "Declared", which means that the organisation has not been fully validated, but the new PIC number can already be used during the proposal submission

The applicants must meet the following conditions at the team level:

- Be an entrepreneurial team, with a minimum of two members.
- Team members must be residents of Portugal or Spain.
- Each team or team member can submit only one application.
- Gender equality and diversity in the team will be positively evaluated.

Individuals or companies that applied to the EIT Manufacturing BoostUp! 2020 competition, in the EIT Manufacturing BoostUp! 2021 RIS competition and in the BoostUp! 2022 and 2023 competitions are NOT eligible.

3.2 Eligible activities

Applications must respect the following eligibility conditions:

- Solutions in the realm of manufacturing technologies, in particular, Net Zero in Industry 4.0.
- Solutions need to fit a least one of the following market segments:

- Proposed solutions that harm the environment or social welfare or discriminate on basis of gender, age, socio-economic and geographic situation, disability, ethnicity, and sexual or gender identity, or are not in line with the Do No Significant Harm Principle are not eligible²
- The proposed solutions must relate to ongoing or completed initiatives. In case of ongoing activities, only work achieved by the submission deadline will be considered for the prize. The solutions proposed can be at different stages of implementation.
- The proposed solutions or activities contained in the application must have taken place in a EU Member State (including overseas countries and territories, OCTs) or in an Associated Country to Horizon Europe.

3.3 Budget and funding

The total maximum EIT funding allocated to this competition is up to 15,000 EUR.

Three winners (ranked 1st, 2nd, and 3rd) of the 2nd phase would be rewarded with:

First prize: 7,000 EUR
Second prize: 5,000 EUR
Third prize: 3,000 EUR

Furthermore, the 10 finalist startups participating to the 2nd phase will receive exclusive "growth packages" of dedicated Access-to-Market support services provided by the EIT Manufacturing Business Development and Innovation team that aims at supporting their internationalization strategy and fostering their innovation. Finalists will also obtain access to EIT Manufacturing's pan-European innovation network and thus enhance their visibility and international publicity through EIT Manufacturing's communication channels.

The "growth package" of dedicated support services provided by the EIT Manufacturing Business Development and Innovation team includes the following:

- Business Development Support
 - o Business strategy and roadmap support
 - o Business Plan and USP Analysis
 - o Commercialisation Plan Analysis (clients, markets)
- Pitch preparation
 - o Message refinement, storytelling, and structure
 - o Rehearsals and Coaching

² Innovations that significantly harm the environment (and therefore contravene the 'do no significant harm' principle of the EU Taxonomy Regulation), social welfare or that are primarily designed for military applications, or in other fields which are generally excluded from EU funding pursuant to Article 18 Horizon Europe Regulation, will not be funded (see Annex 2, General conditions for proposals in the EIC Work Programme 2024 – page 136).

3.4 Payment arrangements

The prize money will be paid to the prize winners after the award ceremony, provided all the requested documents have been submitted (see also point 5.5). In case of a group of winners, the payment will be made to the lead applicant.

Before EIT Manufacturing awards the prize money, the winning companies must provide both their banking and fiscal documentation. Additionally, they must disclose if there are any pending issues with government authorities or agencies per the E.U. funding rules and Horizon Europe legislation.

All winning applicants must sign a "Declaration of Honour" (see also point 6.4), which is annexed to these guidelines. If an issue is identified, EIT Manufacturing reserves the right to withdraw the award of the prize.

3.5 Reporting

Shortlisted finalists must report one (1) month after completion of support from EIT Manufacturing. This reporting must confirm that they received the "growth package" described in section 3.3.

3.6 Ethics and values³

Activities must comply with the highest ethical standards and the applicable EU, international and national law on ethical principles. Moreover, they must respect basic EU values (such as respect for human dignity, freedom, democracy, equality, the rule of law and human rights, including the rights of minorities). The activities must comply with:

- ethical principles (including the highest standards of research integrity) and
- applicable international, EU and national law

Applications that did not respect the above ethical principles and standards cannot be awarded a prize.

4. Proposal preparation and submission

All applications, supporting documents, and materials must be submitted in English using the application forms linked on the competition website (www.eitmanufacturing.eu/calls/boostup-iberia-2024-net-zero) no paper submissions will be considered.

Applicant representatives must register and validate the account if this is the first time accessing the platform. If the applicant's representative has already created an account, the representative can proceed to log in. Once logged in, start a new application. During the application, all compulsory fields must be filled.

The official language of the competition is English (i.e., all submission material must be submitted in English and the representative of the finalist startups must pitch in English, in the final event).

The following documentation must be submitted by the applicants through the submission tool **no later** than the competition deadline on September 23rd 2024 17:00 CEST:

- Application form (including PIC number)
- Company Pitch Deck and the following details shall be clearly outlined:
 - Target markets and description of the main(s) applicative use case(s) addressed by the company offerings and technologies
 - Team and company organization
 - Existing business traction (recurring revenues from commercial activities)
 - o Business development plans (incl. financial aspects) and go-to-European-market strategy
- Company logo in high-quality graphic format (this will be used for the competition promotional campaign)
- Company Registration Certificate (if applicable; see section 3.1, "Applicants profile")

NOTE: Only applications submitted through the online link (as noted above) before the deadline will be accepted and considered. EIT Manufacturing reserves the right to extend the submission deadline; any extension of the deadline will be communicated to the public on the competition website.

Any documentation missing or considered incomplete is a reason for application rejection.

5. Proposal evaluation and selection process

5.1 Eligibility and admissibility check

A proposal will be admissible if:

Applications containing one or more inadmissible and ineligible elements will receive an official communication from EIT Manufacturing setting out the outcome of the eligibility and admissibility check and explaining why the proposal failed to meet the criteria.

The applicant deemed ineligible who disputes the ineligibility decision may appeal. This appeal must be made within 5 working days from the official EIT Manufacturing notification of ineligibility (see paragraph 6.4) by sending an email to support@eitmanufacturing.eu according to the Appeal procedure document linked to the Competition.

5.2 Evaluation of Proposals

The evaluation of the proposals will be conducted in two steps:

5.2.1 1st phase – Online evaluation and selection of finalists

Applicants' proposals will first be reviewed online by a panel composed of 3 evaluators with the same weighting of scores:

- One member from EIT Manufacturing Business Development and Innovation area
- Two external evaluators

The evaluators will be supported by one internal rapporteur.

Each evaluator will have to score each application based on four standardised criteria: Excellence, Impact, Implementation, and Strategic fit.

The criteria and their related sub-criteria will be assessed according to the following scores

| Score | Description | | |

The scores from 1 to 5 shall be given at award criteria level are then summed together to come with a final score:

• Maximum score: 20 points.

• Individual thresholds per award criterion: 3/5 points.

• Overall threshold: 12/20 points.

Applications must pass both the individual (i.e. per award criterion) AND the overall threshold.

The external evaluators will assess each submitted proposal. The Submission Management System "Submittable" will create an average score per application based on the individual evaluators' scorings and produce an Individual Evaluation Report (IER) per application (each application is evaluated 3 times). The external evaluators will meet in a consensus meeting chaired by an independent rapporteur to discuss and reach an agreement. The rapporteur will address any notable divergences between their evaluations and will develop the final Evaluation Summary Reports of the 1st phase.

The top 10 ranked applications will be shortlisted for the 2nd phase –pitching session.

5.2.2 2nd phase –pitching session

The finalist startups will be invited to attend and pitch in person during the pitching session. Shortlisted finalists will be evaluated by a jury panel composed of the same 3 evaluators of 1st Phase with the same weighting of scores. The evaluators will be supported by one internal rapporteur.

The jury panel will refer to the same evaluation criteria and scoring system of the 1st phase (section 5.2.1).

The format of the live pitch will be a 3-minute presentation by the applicants and 3 minutes of questions from the jury panel. The final ranking of the successful applicants will be agreed by the jury members in a consensus meeting, which will take place right after the end of the pitching session and will be chaired by an independent rapporteur. The rapporteur will address any notable divergences between them and will develop the final Evaluation Summary Report of the 2nd phase.

The pitch will happen on December 4th, 2024, in Casa da Música, Porto, Portugal. The agenda for this event will be announced on the competition website (www.eitmanufacturing.eu/calls/boostup-iberia-2024-net-zero). It is the participant's responsibility to keep track of announcements and information on the EIT Manufacturing BoostUp! Iberia Competition website. All shortlisted finalists will also receive an email with the detailed timing of the final pitching competition sessions before the event.

IMPORTANT NOTE: Shortlisted finalists which, for whatever reason, fail to attend the in-person final event at the given time and venue will be disqualified and will not be entitled to any award.

5.3 Communication of results

All applications will be informed about the evaluation result during each phase of the competition.

- 1st phase Online evaluation and selection of finalists: results will be communicated by email to the applicant representatives, registered at the submission platform (Note: Please, check your junk folder). Results will be communicated with a rejection letter, or email to non-qualified applicants, or an invitation email to 2nd phase of the evaluation process. Results will include the Evaluation Summary Reports.
- 2nd phase Live pitch session: a jury deliberation meeting will take place directly after the inperson live pitching session. Right after the decision is taken, the results will be announced publicly during the event. Individual scores and comments made by evaluators will remain confidential.

Based on the evaluation (and after the mandatory checks: ethics review, non-exclusion, double funding and plagiarism, etc), EITM will decide on the award of the prizes to the 3 winners. The winners ranked 1^{st} , 2^{nd} , and 3^{rd} will receive a prize; unsuccessful applications will be rejected.

5.4 Procedure for complaints and appeal

The applicant (the representative of the legal entity) of a rejected application who disagrees with the decision may request an evaluation review. Only procedural aspects of an evaluation may be the subject of a request for an evaluation review, for example, process errors or technical problems. The evaluation of the merits of a proposal shall not be the subject of an evaluation review. In this case, the applicant will have 5 working days after receipt of the final evaluation results to submit an appeal by sending an email to support@eitmanufacturing.eu according to the Appeal procedure document linked to the Competition.

5.5 Selected applicants and follow-up

The selected shortlisted applicants will receive the following awards:

- The ten (10) shortlisted startups (the Finalists) that attend the event and pitch in front of the jury panel will receive the "growth packages" of dedicated support services for two (2) months provided by the EIT Manufacturing Business Development and Innovation team. A dedicated Service Agreement will be signed between each startup and EIT Manufacturing.
- The ten (10) shortlisted startups (the Finalists) will enjoy visibility and international publicity through EIT Manufacturing's communication channels.
- The top three (3) winning startups (the Winners) will receive a financial prize as follows:

First prize: 7,000 EURSecond prize: 5,000 EURThird prize: 3,000 EUR

The shortlisted finalists will have to diligently collaborate in the following steps that will be taken after closing the competition:

- Providing EIT Manufacturing with required banking and fiscal details (applicable to Winners only).
- Signature of a Declaration of Honour (see point 7.8) which can be downloaded from the competition website (applicable to Finalists and Winners).
- Signature of the Service Agreement and/or Financial Prize agreement (the latter applicable to Winners only).
- Collaborate with the Business Development and Innovation team of EIT Manufacturing during the delivery of "growth package" support services.
- Within one month from the end of the Service Agreement or by no later than February 10th, 2025, whichever date comes first: signature of a Support Review Form (SRF) confirming:
 - o The length and type of services provided by the Business Development and Innovation team of EIT Manufacturing and how such services contributed to the startup growth.
 - o The amount, type and source of financing received by the startup during the support period.

The template of the Support Review Document will be provided in due time by the Business Development and Innovation team and shall be signed by a legal representative of the startup.

6. Other terms and Conditions

6.1 Communication, Dissemination, Visibility of funding

Prize winners must promote the prize and its results, by providing targeted information to multiple audiences (including the media and the public) in a strategic and effective manner. Communication activities related to the prize (including media interviews, press statements, presentations, etc., in electronic form, via traditional or social media, etc.), must acknowledge EU support and display the EIT Manufacturing logo (emblem) and text. The emblem must remain distinct and separate and cannot be modified by adding other visual marks, brands or text. Apart from the emblem, no other visual identity or logo may be used to highlight the EIT Manufacturing support. When displayed in association with other logos (e.g. of winners or sponsors), the emblem must be displayed at least as prominently and visibly as the other logos.

For the purposes of these obligations, the winners may use the emblem without first obtaining approval from EIT Manufacturing. This does not, however, give them the right to exclusive use. Moreover, they may not appropriate the emblem or any similar trademark or logo, either by registration or by any other means. Any communication or dissemination activity related to the prize must use factually accurate information.

The EIT Manufacturing may use, for their communication and publicising activities, information relating to the prize, as well as photos or audio-visual material that they receive from the applicants (including in electronic form), and photos and videos taken either in preparation of the award ceremony or during the award ceremony. The EIT Manufacturing will publish the name of both the finalist/s and the selected applicants, their origin, the amount of the prize and its nature and purpose.

6.2 Intellectual Property Rights

Participants retain full and exclusive ownership of their prior information and intellectual property rights. By submitting their application, participants affirm that they hold ownership or have legally secured the right to use all elements of the innovative product or service. Participants agree to indemnify and hold harmless EIT Manufacturing and/or any assignee or affiliate from any third-party allegations or claims of intellectual property rights infringement by the product or service of participants.

Participants shall have the right to further develop, use and license their intellectual property rights for creating, making, marketing and distributing products, services and technology.

Participants agree to respect IPR Rules (Article 16) of the Model Grant Agreement.

Participants also agree to respect the EIT Manufacturing IP Policy.

6.3 Right to activate audits

EIT Manufacturing retains the right to activate an audit on "BoostUp! Iberia 2024" prize winners, in case of alerts and/or to confirm governance and proper usage of the financial prize.

EIT Manufacturing keeps the right to request any data related to the "BoostUp! Iberia 2024" competition to the prize winners during 5 years after completion to ensure transparency and allow monitoring from EIT.

6.4 Withdrawal of the prize - Recovery of undue amounts

Applicants which are subject to an **EU exclusion decision** or in one of the following **exclusion situations** that ban them from receiving EU funding can NOT participate⁴:
